A few years ago I attended the historical NYSUT Representative Assembly at which we witnessed the merger of NEA-NY and NYSUT. This past weekend was the 42nd NYSUT Representative Assembly and was no less historic. Sonia and I served as your elected delegates and witnesses to this event. The 42nd RA Convention was the first time in NYSUT's history where all the elected officers were in contested elections, as were many seats on the Board of Directors. The convention was a full force campaign in the midst of all the other work of the delegates. The air was often tense, as close friends of many years saw themselves supporting opposing candidates. Union brothers and sisters would avoid one another or engage in only polite conversation ignoring the campaign for but a moment. The convention was awash with groups of friends socializing while wearing symbols of competing candidates in a dance of silent avoidance. Then there were those who spoke openly with each other, not in an attempt to change one another's mind but to begin bridging the gap for the future. We would all have to work together for the benefit of NYSUT, our members and the students we serve. We spoke of reaching out to one another in the immediate hours following the close of the convention on Sunday. One slate of candidates began early using #commonground to begin the paving of the way to the future. The final speech by one of NYSUT's officers ended with the line, regardless of the election results, we are all united.

The entire weekend was stressful yet invigorating and powerful. I found myself trying to mend the fences between competing sides while at the same time promoting our candidates. The courting of support for ones chosen candidates was at the forefront of almost every interaction, it seemed to envelop the delegates. This internal election, pitting friend against friend and neighbor against neighbor was felt by all. To help with the whirlwind, I spent the last few hours before the election on the convention floor, alone. I participated in the proceedings while at the same time mulling over the election in my head. During this time, all of the delegates as one unified voice:

- 1. Acknowledged the teacher of the year.
- 2. Expressed solidarity with the teachers and students in Philadelphia.
- 3. Supported parents rights to make educational decisions for their children by opting out of testing. And
- 4. We unanimously passed a resolution calling for the immediate removal of Commissioner King. In the midst of the election we showed NYSUT was still unified. The work for paving the common ground had begun.

Then it was election time, we all went to cast our votes and it was over. I overheard one delegate comment "What's done is done". She was right, and now the rebuilding could begin. As I write this, the results will not be known for quite a few hours.

The results are now known, and the slate of candidates supported by the PEA were victorious and will soon take office. Now begins the arduous task of moving NYSUT forward. To help with this process, Sonia has been asked to serve as assistant to the NYSUT President. What an incredible honor to be recognized for her talents. This is good for NYSUT as Sonia's skills will be invaluable to our newly elected President Karen Magee. It is good for

Message from PEA Treasurer, Michael Pray

Dear PEA Members,



As we move into the April through June PEA calendar year, I find myself beginning the arduous process of establishing a PEA budget for the 2014/2015 school year that is fiscally sound and addresses the needs of the PEA organization in the years ahead.

At the April executive committee meeting, I will put fourth a rough draft of the '14/'15 PEA budget for discussion and input from the executive committee members. At the May executive meeting, I will propose, for a vote, the PEA '14/'15 budget. If passed there, it will move forward to be voted on at the General Membership meeting in June.

As this process begins, I have been asked to give **a state of the PEA financials** <u>to date</u> for your consideration.

Currently, we are 75% through the PEA financial calendar year- which begins in August. All of the PEA expenditures are below the 75% mark <u>at this time</u> with the exception of the expenditures that have gone towards membership services- which is at 74%. We have spent 49% of our \$58,000 budget. Our gross income is currently at \$44,500 and comes from such things as dues, Vote-Cope rebates, interest, and miscellaneous items such as payment from NYSUT ads in our *Broadside*. At our current dues structure, we take in about \$6000 per month, from dues, to go towards operating expenses.

A note here is appropriate to explain that a budget is "unrealized" money that was and will be estimated to ensure the viability of the PEA. Gross income is actual money that can be used in the execution of PEA activities and responsibilities. **The expenses to income ratio has been very positive in the last few years and your PEA remains financially strong**.

The PEA scholarship fund program collects \$245, in total, per pay period. This money goes directly into the Scholarship savings account and supports four aspiring college students with their education towards a career in teaching. This program, along with the many fundraising activities such as the chili cook offs, benefits fair raffles, and PEA branded item sales helps us to reach that needed goal of \$4000 without dipping into our gross receipts.

Lastly, and secondary to our budget, is the Local Action Plan (LAP) budget. This program has been a boon to our PEA in that it has allowed the PEA to "experiment" with and execute new programs focused on the membership, community, political action, and communications without having a significant impact on the dues money collected from members.

It is my opinion, as your treasurer, that, while adjustments will always be necessary to both the expenses and the income aspects of any future budget, **the PEA is currently in a favorable financial position to meet its goals or to weather any storms that may appear on the horizon**.



School Psychologists Tackle Tough Issues

School psychologists provide effective services to help children and adolescents succeed academically, socially, behaviorally, and emotionally. We provide direct educational and mental health services for children and youth, as well as work with parents, educators, and other professionals to create supportive learning and social environments for all children.

School psychologists provide services to schools and families that enhance the competence and well-being of children, including the promotion of effective and safe learning environments, prevention of academic and behavior problems, response to crises, and improvement of family- school collaboration. The key foundations for all services by school psychologists are the understanding of diversity in development and learning; research and program evaluation; and legal, ethical, and professional practice.

The National Association of School Psychologists (NASP) promotes a Model for Comprehensive and Integrated School Psychology Services. The model promotes a high level of services to meet the academic, social, behavioral, and emotional needs of all children. The professional practice of school psychologists permeates all aspects of service



delivery: data-based decision making and accountability; consultation and collaboration; interventions and instructional support to develop academic skills; interventions and mental health services to develop social and life skills; school-wide practices to promote learning; preventive and responsive services; family-school collaboration; as part of an interdisciplinary team, conduct assessments to identify students' eligibility for special education and other educational services; use valid and reliable assessment techniques to assess progress toward academic and behavioral goals, to measure responses to interventions, and to revise interventions as necessary.

Comprehensive strategies to increase safety in schools must include addressing the mental health needs of children and creating safe and supportive environments that diminish the likelihood of violent behavior. School psychologists can be instrumental in broadening the focus beyond the historical practices of primarily increasing building safety (e.g. metal detectors, security guards, surveillance cameras) and instead focus on addressing the continuum of needs and services that lead to improved safety, well-being, and learning for all children and youth. School mental health supports that encompass social-emotional learning, mental wellness, resilience, and positive connections between students and adults are essential to creating a school culture in which students feel safe and empowered to report safety concerns, which is proven to be among the most effective school safety strategies.

The ratio of school psychologists to students is a critical aspect of the quality of services to students.

To ensure the delivery of the necessary comprehensive school psychological services and ensure quality of student outcomes for all Penfield children and youth (K-12), the Penfield Central School District should maintain a ratio not to exceed 500 students to 1 school psychologist.

Know Your Contract

Section 6-10 Involuntary Transfers

No unit member who is involuntarily transferred shall lose his/her tenure or be deprived of any other professional advantage.

-and further....

Notice shall be given to Special Education unit members no later than June 30th of an involuntary transfer. In the event that the notification is after June 30th, the unit member has the option as to whether or not they accept the transfer. Unit members who accept an involuntary transfer after June 1 will be entitled to receive one (1) day of paid summer work (\$35.00 based on a 7hour work day) in order to familiarize themselves with the new building.

Birth of Rose Schneiderman, prominent member of the New York Women's Trade Union League, an active participant in the Uprising of the 20,000, the massive strike of shirtwaist workers in New York City led by the Int'l Ladies' Garment Workers' Union in 1909, and famous for an angry speech about the 1911 Triangle Shirtwaist Factory fire: "Every week I must learn of the untimely death of one of my sister workers.... I know from my experience it is up to the working people to save themselves. The only way they can save themselves is by a strong working-class movement" - 1882
